

# Privacy Statement

## **General terms and conditions**

### **Registration**

Registering for the online quantum self-healing program Creascopy is done by sending an email to [info@jolandasimons.online](mailto:info@jolandasimons.online) after which a confirmation follows. This makes the registration final and the invoice will be sent digitally as a PDF.

### **Term of payment**

A payment period of 7 days applies to the invoice. Because Creascopy is a self-healing program participation cannot be transferred to third parties.

When the invoice has been paid to the account of Jolanda Simons, the program is started. The start and end date are confirmed by email.

### **Cancellation**

You can cancel your registration for participation in the online self-healing program free for charge up to 3 days after registration. Cancellation must be notified by e-mail, after which the cancellation is confirmed with the confirmation of receipt from Jolanda Simons. After these three days, cancellation is no longer possible and the registration is final. Refund of funds is then no longer possible.

## **Protection of personal data**

In order to facilitate and guide your self-healing Jolanda Simons needs personal information from you. These personal details are never provided or sold to third parties. Jolanda Simons processes personal data only for the purpose for which they were provided and in accordance with the General Data Protection Regulation (AVG) and the Telecommunications Act.

## **Data protection**

The Cosmic Shell Academy has taken appropriate technical measures to protect personal data against loss or other forms of unlawful processing. The SSL-certificate provides a security level that matches the data that we process.

## **Retention period and deletion of personal data**

The Cosmic Shell Academy does not store your data for longer than necessary for the purpose for which it was received. At the end of the self-healing program all personal data will be deleted from the system at the end of the month concerned, with the exception of the data required for submission to legal authorities.

We keep the data in our accounting system for at least 7 years in order to meet our legal obligations. This data will be deleted by us within 1 year of the expiration of this obligation. The above period applies, provided that there are further legal obligations for us to keep the data longer and/or keep it available.
